RENTAL AGREEMENT

All equipment rentals shall be governed by the following terms:

The Lessee agrees to pay rental price for the equipment rented. Should said equipment, or any part thereof, be lost, damaged, or destroyed, by fire, casualty of any kind, act of God or other act or accident, Lessee agrees to pay for repair or replacement of said equipment. Rental for said equipment shall continue until said equipment has been repaired or replaced. In determining whether equipment shall be replaced or repaired, Lessor's arbitrary judgement in this respect shall be conclusive upon Lessee.

Equipment so damaged or lost shall be paid for within ten days after said event.

The Rosenthal Group is in no way responsible for any liabilities, claims, costs or expenses arising out of the use or possession of its equipment. Our equipment is offered for inspection and test prior to the beginning of the rental.

All shipments made by air or surface at renter's request will be shipped collect for freight charges. All rented equipment returned to The Rosenthal Group must be shipped prepaid. Rental does not end until equipment is received at our facility.

All units unless otherwise indicated are furnished with globes. All furnished globes including burn-outs must be returned or they will be charged. Customer shall pay for all broken bulbs, bulbs subjected to improper handling, burn position, burn environment or voltage. Customer shall also pay for burn-outs on rentals exceeding one week.

Lessee, at it's own expense, agrees to furnish Lessor with **CERTIFICATE OF INSURANCE** prior to release of equipment, with coverages as follows:

INSURANCE REQUIREMENTS FOR EQUIPMENT:

(a) MISC. EQUIPMENT COVERAGE: Minimums shall vary according to the value of the total equipment rented, and shall not be less than the full replacement value of all equipment rented. Coverage to include all listed equipment for "ALL RISK" perils, and contain a LOSS PAYABLE clause endorsement stated as follows: Effective _____(date)_____, it is understood and agreed that the certificate holder is recognized as LOSS PAYEE as respects _____(Value Amount)_____ misc. rented equipment and that said policy is primary and not in excess of, or contributory to, any other insurance provided for the benefit of, or by, the certificate holder. Limits of Lessee's insurance shall not limit lessee's liability.

(b) GENERAL LIABILITY COVERAGE: Minimum of \$1,000,000 combined single limits, bodily injury and property damage, is to maintained for the term of the rental. THE ROSENTHAL GROUP is to be named as ADDITIONAL INSURED, as respects the rental of this equipment during the term of this rental agreement.

(c) Show evidence of Worker's Compensation coverage.

INSURANCE REQUIREMENTS FOR VEHICLES:

If a vehicle is rented, THE ROSENTHAL GROUP, is to be provided with a certificate of insurance providing:

(a) No less than \$1,000,000 combined single limits, Automobile Bodily Injury, Property Damage, and PHYSICAL Damage and shall include HIRED and NON-OWNED Auto.

(b) THE ROSENTHAL GROUP shall be named as ADDITIONAL INSURED and LOSS PAYEE for the duration of the rental.

(c) In the event of damage, The Lessee shall pay the full cost of all necessary repairs as well as the full weekly (4 day week) rental until the vehicle is placed back in service.

The Rosenthal Group does not provide employee drivers for its vehicles. All vehicles are rented with the understanding that WE DO NOT ACCEPT RESPONSIBILITY FOR UNSAFE OR UNQUALIFIED DRIVERS HIRED BY LESSEE. THE LESSEE ACCEPTS COMPLETE RESPONSIBILITY FOR VERIFICATION OF THE GOOD DRIVING RECORDS OF THE DRIVERS THEY HIRE AND THEIR QUALIFICATIONS TO OPERATE THE VEHICLE BEING RENTED.

Maximum deductible of \$1,000.00 shall be accepted on vehicle and \$2,500 on equipment with Lessee entirely responsible for the deductible portion. The Rosenthal Group, at its sole option, may require a cash deposit equal to the deductible portion of Lessee's insurance.

Interest of 1.5%/month shall accrue on all past due balances.

Minimum rental period is one day. Equipment must be returned before 10AM the following business day or additional rental charges will apply. Unless indicated otherwise, all equipment is rented as a complete unit as defined in the most current Rosenthal Group price list.

These standard rental terms or the most current version of the Rosenthal Group standard rental terms shall apply to all rentals made by the Lessor to the Lessee.
